ORDINANCE NO. 3056 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AMENDING CHAPTER 19 OF THE CITY'S CODE OF ORDINANCES ENTITLED "TRAFFIC AND MOTOR VEHICLES" BY CREATING A NEW ARTICLE VI WHICH ESTABLISHES A MOTOR VEHICLE COST RECOVERY FEE FOR COSTS INCURRED BY THE POLICE DEPARTMENT IN RESPONDING TO MOTOR VEHICLE ACCIDENTS; ALLOWING A FEE SCHEDULE TO BE ADOPTED BY RESOLUTION; PROVIDING FOR THE BILLING OF VEHICLE OWNERS AND

INSURANCE COMPANIES FOR THE FEES; PROVIDING FOR A SEPARATE FUND AND LIMITING THE EXPENDITURE OF THE FEES COLLECTED; PROVIDING FOR THE ENGAGEMENT OF A THIRD PARTY COLLECTION AGENCY TO COLLECT THE FEES; PROVIDING FOR CONFLICTS, SEVERABILITY, AND CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

**Chair pro tern Pardo** expressed words of appreciation to those who made the toy drive a success.

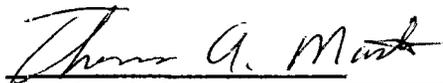

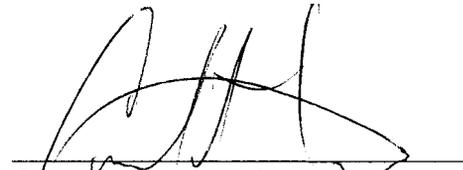

**There being no further discussion, the meeting was duly adjourned at 10:40 p.m.**

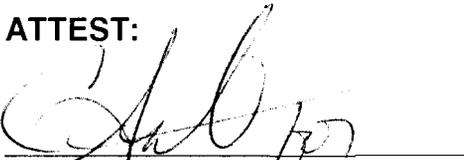

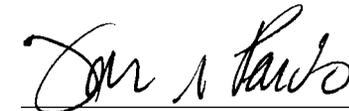

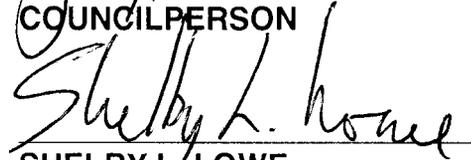
