As required by law, all publications were completed. There were precinct locations changed and notifications was emailed -- was mailed to all affected residents whose names and addresses were obtained from the Palm Beach County Supervisor of Elections Office. Notification was also placed on the City's website, channel 18, and signage was posted at the previous location notifying voters of their precinct's location.

As the Supervisor of Elections for the City of Riviera Beach, March 10, 2015, Municipal Election, the following resolution certifying the results of said election is being presented to the Canvassing Board for adoption.

COUNCILPERSON T. DAVIS: No, ma'am.


6) ADJOURNMENT




