SUMMARY/BACKGROUND:

Pine Point Road is a stretch of residential roadway located on Singer Island that extends from State Road A1A to the west where it dead ends at a cul de sac. Pine Point Road residents, with concerns over safety and lack of adequate lighting, requested that lighting be installed to replace the current aged lighting that does not provide sufficient levels of light along the road and at most of the adjoining residences. The wiring for the existing lighting, over time, got damaged due to various excavation operations performed by either residents or utility companies and has caused some lights to be nonoperational. The residents have requested the City install decorative lighting on Pine Point Road. Staff had the electrical plan for the installation prepared by an electrical engineer, Techno Engineering. The estimated cost for the purchase and installation of the 16 poles and fixtures is \$130,000.

Staff recommends approval of the resolution authorizing staff to solicit bids for a contractor to purchase and install decorative lighting on Pine Point Road.


