



Greetings.


Please disregard the letter dated October 26th 2009 in which I recommended Ms. Dorothy Edwards for the position of Resident Board Member. I have tried in vain to contact Ms. Edwards to set up the meeting you requested to have with her. This seem to be an issue which the Riviera Beach Housing Authority may face in the future and so we wish to withdraw this recommendation.

In her place, I would recommend Mr. Willie Patterson, a former resident of the Ivey Green Village elderly building until recently when he was awarded a the Department of Housing & Urban Development Section 8 housing program Voucher and re-located to and now resides at 1143 West 23rd Street, Riviera Beach, FL 33404.

The By-Laws of the RBHA states under ARTICLE 1- Section 4. **Board of Commissioners:** *"The Authority shall have five (5) Commissioners one of whom shall be a resident of the Authority who shall be appointed by the Mayor of the City of Riviera Beach..."*. The former resident commissioner has vacated his seat at the board.

As the board currently have four members, there may occur a tie vote on any matters requiring a vote and the appointment of Mr. Patterson would remove this unlikely possibility.
