SECTION 2. That the Finance Director is authorized to make payment from Account Number 001-0512-5190-3101 for services rendered under this contract.

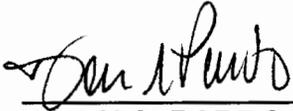
SECTION 3. This Resolution shall take effect upon passage and adoption by the City Council.

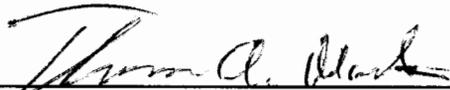
SECTION 1. The City Council hereby authorizes and approves the payment to C & C landscaping in the amount \$2,010.00 for lot cleaning and a related services.

SECTION 2. The Finance Director is hereby authorized to make payment from Account No. 430-0841-524-0-4601.

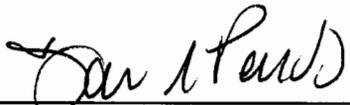

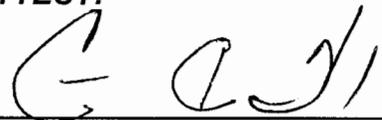

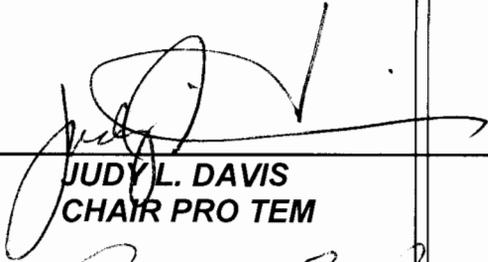

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A VOLUNTARY BUYOUT INCENTIVE PROGRAM AND AUTHORIZING THE CITY MANAGER TO IMPLEMENT THE PROGRAM WITH EMPLOYEES WHO VOLUNTARILY PARTICIPATE; AUTHORIZING THE FINANCE DIRECTOR TO MAKE PAYMENT FROM THE SALARY ACCOUNTS OF THE RESPECTIVE DEPARTMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City is in the process of developing the fiscal budget for the year 2010/2011; and

WHEREAS, the current economic downturn and decline in property values have reduced the amount of revenue the City collects in order to cover costs; and

WHEREAS, personnel costs make a large percentage of the City's overall budget; and

WHEREAS, the City is offering a Voluntary Buyout Incentive Program to employees in an effort to reduce personnel costs.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA, THAT:

Section 1: The City Council approves the Voluntary Buyout Incentive Program, as attached, and authorizes the City Manager to implement the program with employees who voluntarily participate.

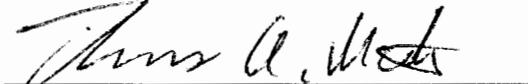
Section 2: The Finance Director is authorized to make payment to employees that participate from the respective department's salary accounts.

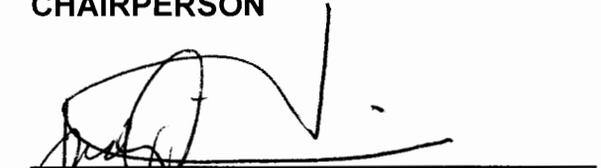

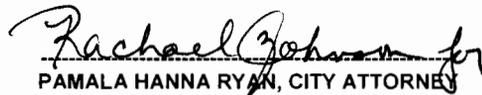
