OF HOMESTEAD, FL BY PIGGYBACKING OFF PALM BEACH COUNTY'S ANNUAL ROADWAY LANDSCAPING CONTRACT NUMBER 2005055; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE MATERIALS AGREEMENT; AND AUTHORIZING THE INTERIM FINANCE DIRECTOR TO TRANSFER FUNDS IN THE AMOUNT OF \$82,000 FROM VARIOUS PUBLIC WORKS ACCOUNTS TO PUBLIC WORKS STREETS ACCOUNT NO. 001-1127-5410-5307; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, approximately twenty three (23) Foxtail Palm Trees at the entranceway of Blue Heron Boulevard, east of 1-95 are in dire need of replacement; and

WHEREAS, the Palm Beach County Contract has been extended for an additional twelve months (expiring September 30,2007); and

WHEREAS, Arazoza Bros., Corp. was awarded the County's Annual Roadway Contract through a bid process.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA AS FOLLOWS:

SECTION 1. That the City Council hereby authorizes the purchase and planting of twenty four (24) palms, four (4) Royal Palms, five (5) trees, and other plants from Arazoza Bros., Corp. of Homestead, in the amount of \$81,125.00.

SECTION 2. That the Mayor and City Clerk are authorized to execute the attached Materials Agreement for said purchase.

RESOLUTION NO. 103-07

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A SPECIAL EXCEPTION APPLICATION FROM LORETTA FERGUSON FOR AN ADULT CARE FACILITY ON 5,750 SQUARE FOOT PROPERTY LOCATED AT 936 WEST 36TH STREET, RIVIERA BEACH, FLORIDA IN A MULTIPLE FAMILY RESIDENTIAL (RM-15) ZONING DISTRICT; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 31-62 of the City of Riviera Beach Land Development Code establishes the requirements for granting Special Exception applications; and

WHEREAS, the Planning and Zoning Board met July 12, 2007 to review the Special Exception application and made a recommendation to the City Council for approval of the application, with conditions; and

WHEREAS, the City Council has considered the application, the evidence submitted by the applicant and finds that the proposed Special Exception is consistent with the City of Riviera Beach Code of Ordinances, Section 31-62: 'Standards for granting special exceptions' based on the conditions identified within Section 1.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AS FOLLOWS:

SECTION 1. The Special Exception Application for the operation of a Adult Care facility, which will house two to five ambulatory elderly residents at lease 60 years old in a single family home, approximately 2,720 square feet in size on a 5,750 sq. ft. parcel, located at 936 West 36th Street, Riviera Beach is hereby approved with the following conditions:

1. Background and criminal record checks be performed by the applicant for all employees and records of employees are kept on file at the facility at all times.
2. A maximum of five (5) residents, including the operator, may reside at the facility at any given time.
3. Approval of the use would not be carried forward to future licensees. The licenses must remain in the name of Ms. Loretta Ferguson and *Rainbow Adult*

Family Care Home. (This condition is intended to prevent the applicant from transferring the Special Exception Use to another owner/tenant without obtaining City Council approval)

4. Any expansion of the Adult Care Facility must first be approved by the City Council.

5. A maximum of three (3) cars can be parked at the facility at any given time and no parking is allowed on the street directly adjacent to the facility; violation of this condition will require a reexamination of the Special Exception by the City Council.

SECTION 2. This Resolution shall act as the final order, which must be recorded in the public records of Palm Beach County by the applicant upon this approval.

SECTION 3. This Resolution shall take effect immediately upon its passage and approval by the City Council.

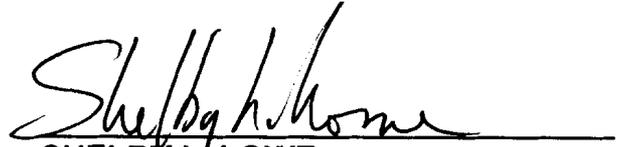

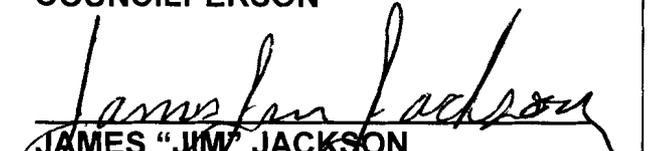

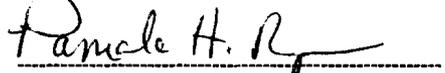

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, ACCEPTING FUNDS FROM PALM BEACH COUNTY 911 EMERGENCY MANAGEMENT IN THE AMOUNT OF \$78,104 TO PROVIDE FOR A GRANT REIMBURSEMENT OF PUBLIC SAFETY ANSWERING POINT (PSAP) OPERATIONS; AUTHORIZING THE FINANCE DIRECTOR TO INCREASE THE 2006-2007 911 GRANT BUDGET FOR THE SAME; AUTHORIZING THE PAYMENT OF A ONE TIME BONUS TO COMMUNICATIONS OPERATORS/SUPERVISORS TOTALING \$29,918 TO BE PAID FROM THE 911 GRANT FUND ACCOUNT NUMBER 124-0819-521-0-1201; AUTHORIZING THE PURCHASE OF EQUIPMENT TOTALING \$48,186 TO BE PAID FROM ACCOUNT NUMBER 124-0819-521-0-6405; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Riviera Beach has received a reimbursement grant from Palm Beach County 911 Emergency Management in the amount of \$78,104; and

WHEREAS, the City Council of the City of Riviera Beach, Florida accept the funds from the Palm Beach County 911 Emergency Management in the amount of \$78, 104; and

WHEREAS, the Police Department deems that a one time bonus in the amount of \$29,918 be paid to the Communications Operators/Supervisors who are employed on the date the money is paid so that it will increase the retention and recruitment of qualified communications staff; and

WHEREAS, \$48,186 of said reimbursement be allocated for operating expenditures; and

WHEREAS, the Police Department Communications Section is in need of additional equipment and desires a Communications Training Center.

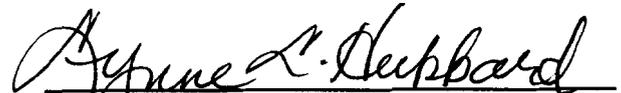

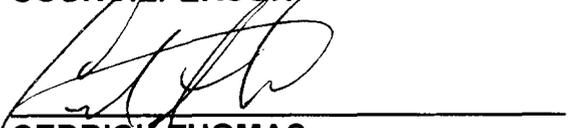

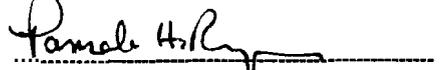

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING JORDAN, JONES & GOULDING, INC. OF PALM BEACH GARDENS, FLORIDA FOR DEVELOPING AND IMPLEMENTING A STORMWATER MASTER PLAN FOR THE CITY OF RIVIERA BEACH IN THE ESTIMATED AMOUNT OF \$785,000.00; AUTHORIZING THE CITY MANAGER TO MAKE AND INITIATE CHANGE ORDERS UP TO TEN PERCENT (10%) AND AUTHORIZING THE INTERIM FINANCE DIRECTOR TO PAY THESE AMOUNTS FROM THE STORMWATER MANAGEMENT UTILITY CONTRACT SERVICES ACCOUNT 460-1127-541-0-3101 AND PROVIDING AN EFFECTIVE DATE.

SECTION 1. The City authorizes Stormwater Management Utility to hire Jordan, Jones and Goulding, Inc. as the Stormwater Master Plan services firm in the development and implementation of the Stormwater Master Plan for the price of \$785,000.00.

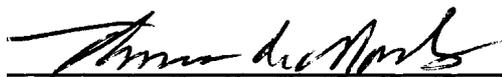

RESOLUTION NO. 106-07 -

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING AN INTER-LOCAL AGREEMENT BETWEEN PALM BEACH COUNTY BOARD OF COUNTY COMMISSIONERS AND THE CITY OF RIVIERA BEACH TO ESTABLISH A MICROWAVE TOWER SITE ON THE CITY'S RADIO COMMUNICATIONS TOWER, COMMENCING UPON THE SIGNING OF THIS AGREEMENT AND APPROVING A CHANGE ORDER IN THE AMOUNT OF \$104,274.00, IN THE CURRENT SERVICE AGREEMENT BETWEEN THE CITY OF RIVIERA BEACH AND MOTOROLA, INC.; AUTHORIZING THE MAYOR AND CITY CLERK TO SIGN SAID AGREEMENT; AUTHORIZE THE EXPENDITURE STATE LEGISLATED APPROVED \$12.50 FUNDS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Palm Beach County desires to establish a microwave tower site within the corporate city limits; and

WHEREAS, the City desires to become configured in the Palm Beach County Board of County Commissioners microwave communications system connected by County tower sites by contracting with the County; and

WHEREAS, the inter-local agreement is to commence upon the date in which the agreement is signed; and

WHEREAS, Palm Beach County Board of County Commissioners has submitted an inter-local to establish the City's microwave system as a part of the Palm Beach County microwave Tower Site configuration at no cost to the City; and

WHEREAS, this agreement will eliminate recurring costs associated with current T-1 data communications lines used to connect to Palm Beach County's 800 MHz SmartZone System radio; and

WHEREAS, Motorola is currently installing a radio tower and microwave system for the City and has submitted a change order to the current contract for service in the amount of \$104,274, equipment and labor, to facilitate the agreement with Palm Beach County Board of County Commissioners.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA, THAT:

SECTION 1. The City Council authorizes the Mayor and City Clerk to sign said inter-local agreement on behalf of the City.

SECTION 2. Staff is authorized to sign said change order to the current service agreement with Motorola Corp. on behalf of the City.

SECTION 3. Finance Director and staff are authorized to complete the necessary documents in order to disburse State Legislated \$12.50 funds to cover costs associated with said Motorola change order.

SECTION 4. The Finance Director is authorized to make payment of \$104,274 to Motorola Corp. for changing the current service agreement between the City and Motorola to install a radio tower and microwave system.

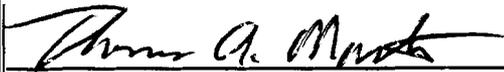

SECTION 3: This resolution shall take effect upon its passage and approval by the City Council.

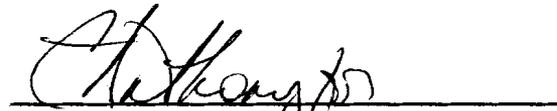

WHEREAS, property located at 1546 Martin Luther King Blvd. was found to be in violation of the City's Code of Ordinances on August 22, 2001, pursuant to Case No. CEB 01-144; and

WHEREAS, that portion of Avenue uR" south of Silver Beach Road to Blue Heron Boulevard is a platted road right-of-way; and

WHEREAS, Reverend R. J. Hendley was a respected city leader who recently passed away; and

WHEREAS, the City Council of the City of Riviera Beach finds that it is appropriate to honor the memory of Reverend R. J. Hendley by renaming Avenue R from Silver Beach Road south to Blue Heron Boulevard to R. J. Hendley Avenue.

Section 1. The City Council approves the renaming of Avenue "R" from Silver Beach Road south to Blue Heron Boulevard to R. J. Hendley Avenue.

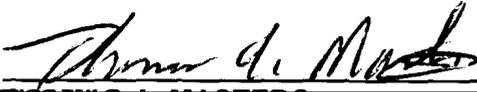
Section 2. That the City will transmit the street name change to the Florida Department of Transportation and the Post Office.
