**SECTION 4.** The Finance Director is authorized to make payment for same from account number 310-0716-5410-6355.

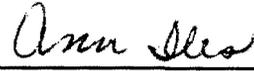

**WHEREAS**, the attrition of personnel and a budget transfer of \$39,264 from the Overtime line to the Regular Salaries line will permit the Police Department to fund the additional lieutenants from the existing FY2007 budget.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:**

**SECTION 1:** The City Council approves the temporary increase in the complement of police lieutenants, to fourteen (14), until April 1, 2007, at which time the three temporary lieutenant positions created by this action will be eliminated.

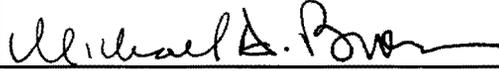
