A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING THE LOCATION OF THE PROPOSED HIGH SCHOOL (MMM) CONTAINED WITHIN THE GEOGRAPHICAL BOUNDARIES OF THE REDEVELOPMENT AREA WHICH IS BOUNDED ON THE NORTH BY 18TH STREET, ON THE SOUTH BY 13TH STREET, ON THE WEST BY OLD DIXIE HIGHWAY, AND ON THE EAST BY AVENUE "F"; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

WHEREAS the City of Riviera Beach is desirous of locating a new high school within the City; and

WHEREAS, the City Council of the City of Riviera Beach held a public meeting on August 5, 2004, concerning the proposed location of the new high school; and

WHEREAS, the City Council forwarded its recommendation for a new high school to the Palm Beach County School Board; and

WHEREAS, the Palm Beach County School Board met on August 18, 2004 and approved the recommended site of the proposed high school (MMM) in the City of Riviera Beach.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1. That the City of Riviera Beach approves the recommended site as the location of the MMM High School within the geographical boundaries of 18th Street to the north, 13th Street to the South, Old Dixie Highway to the West, and Avenue "F" to the East.

SECTION 2. This Resolution shall take effect immediately upon its passage.

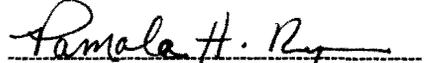

RESOLUTION NO. 213-04

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AN AGREEMENT WITH R.G. GROUP, INC., d/b/a/ TIKI WATERFRONT SEA GRILL TO OPERATE A RESTAURANT FROM THE CITY OF RIVIERA BEACH MUNICIPAL MARINA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Riviera Beach wishes to enter into a new lease agreement with R.G.Group, Inc., d/b/a/ Tiki Waterfront Sea Grill; and

WHEREAS, the lease agreement will allow Keith Ragon and Robert Gregory to utilize space at the Riviera Beach Municipal Marina to operate R.G.Group, Inc., d/b/a/ Tiki Waterfront Sea Grill, a restaurant, lounge and store; and

WHEREAS, the lease agreement will become effective on January 1, 2005.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA AS FOLLOWS:

Section 1. That the City Council approves the lease agreement with R.G.Group, Inc., d/b/a/ Tiki Waterfront Sea Grill.

Section 2. That the Mayor and City Clerk are authorized to execute the agreement on behalf of the City.
